On September 30, 2025 Kezar Falls Hydro, LLC ("KFH"), filed the Pre-Application Document (PAD) for the Kezar Falls Hydroelectric Project (FERC Project No. 9340) (Project) with the Commission. The Kezar Falls Project is located on the Ossipee River in York and Oxford Counties, Maine. On December 4, 2025, the Commission granted approval for KFH to use the Traditional Licensing Process (TLP) for the Kezar Falls Project.

This letter is to notify the Commission that KFH will host the Joint Agency & Public Meeting (Joint Meeting or meeting) for the Project on Friday, January 23, 2026 at 9:00 AM ET at "The Perkins House" located at 3 Old School St. Cornish, ME. A site visit of the Upper Kezar Falls Project located 1 Mill St, Parsonsfield, ME 04047 and then to the Lower Kezar Falls Project located at 30 Power House Rd, Parsonsfield, ME 04047 will immediately follow the meeting.

Attached is a copy of the public notice for the meeting, which will be published in the Kennebec Journal and Morning Sentinel, newspapers having distribution Oxford County and in the Portland Press Herald, a newspaper having distribution in York County, where the Project is located. Proof of publication will be filed with the Commission once available. Additionally, this notification is simultaneously being distributed to the resource agencies and interested parties listed in the Project Distribution List, in accordance with FERC regulations.

KFH kindly requests that resource agencies and interested parties, including members of the public, who plan to attend the Joint meeting and/or the site tour RSVP helen.jasper@eaglecreekre.com on or before January 20, 2026. Additionally, those planning to participate in the site visit should wear hard-soled shoes, such as work boots or hiking shoes, and long pants. Please note that persons under 16 years of age will not be permitted in non-public areas of the Project.


The meeting agenda includes: Introductions, Project Overview, FERC Licensing Process, Environmental Considerations, Next Steps, and Site Visit (optional).

Notice of Joint Agency and Public Meeting with the Federal Energy Regulatory Commission

Kezar Falls Hydroelectric Project (FERC No. 9340)

Kezar Falls Hydro, LLC hereby notifies resource agencies, Indian tribes, and stakeholders, including members of the public, that it will host a Joint Agency Meeting (JAM) and Site Visit on Friday January 23, 2026 to discuss the Federal Energy Regulatory Commission (FERC) relicensing of the Kezar Falls Hydroelectric Project (FERC Project No. 9340). The 1 MW hydroelectric project is located on the Ossipee River in York and Oxford Counties, Maine. The purpose of the meeting is to 1) provide information about the Project Licensing process; 2) solicit information regarding the existing environmental resources associated with the Project and data that may need to be obtained; and 3) obtain agency and stakeholder opinions regarding the Project and its potential effect on existing resources.

The JAM will be held at 9:00 AM ET at “The Perkins House” at 3 Old School St. Cornish, Maine. The Site Visit will be held immediately following the JAM at the Upper Kezar Falls Powerhouse located 1 Mill St, Parsonsfield, Maine, 04047.
