Midwest Hydro, LLC (Midwest Hydro, Licensee, or Applicant), a wholly owned subsidiary of Eagle Creek RE Management, LLC (Eagle Creek), is the owner and operator of the Janesville (Central) Hydroelectric Project (Janesville Project) (FERC No. 2347) and the Beloit (Blackhawk) Hydroelectric Project (Beloit Project) (FERC No. 2347). The Projects are located on the Rock River in Rock County, Wisconsin. The Janesville Project is located in the City of Janesville and the Town of Janesville. The Beloit Project is located in the City of Beloit, Town of Beloit, and Town of Rock. The current licenses expire on August 31, 2024.

Midwest Hydro is hereby filing the Final License Applications (FLAs) for the relicensing of the Janesville and Beloit Hydroelectric Projects. The Licensee has prepared these FLAs to conform to the requirements of the Commission's regulations at 18 CFR §§ 4.38, 4.61, and 16.10 as required under the Traditional Licensing Processes (TLP) that were approved by the Commission on October 16, 2019. Pursuant to 18 CFR § 4.38 and by copy of this letter (via email and/or US mail), the Licensee is providing a link to the Project's relicensing website at <https://www.eaglecreekre.com/facilities/operating-facilities/rock-river-hydro-facilities/rock-river-relicensing-information>. It should be noted that there are three differences between the information filed with the Commission and the information provided to the stakeholders. The differences are as follows:


